NOTICE is hereby given that the TWIN 52 lode mining claim has been located by KENNECOTT CORP., whose office is located at P.O. Box 11248, Salt Lake City, Utah 84147.

By right of discovery, the locator does hereby claim all valuable minerals together with all extralateral variations allowed by law. This claim is 1500 feet in length, and 600 feet in width. The general course of this claim is North-South and is situated in the unknown Mining District, Eureka County, State of Nevada. This claim runs from the location monument upon which this notice is posted, 10 feet in a South direction to the S end line, and 1400 feet in a North direction to the N end line, together with 300 feet on each side of the center of the vein.

This claim is monumented by six posts, one at each corner and one at the center of each side line of the claim, taking the form of a parallelogram. The claim is situated in the SW quarter of Section 30, Township 19 N, Range 50 E, MOB&M.

The location of this claim in relation to some natural object or permanent monument is as follows: The SW corner of Twin 52 is approximately 8,450 feet in a N 45 E direction from the NE corner of Sec. 2, T 18 N R 49 E

The boundaries of this claim can be identified by the following description. BEGINNING AT THE NE CORNER OF THE CLAIM, ALSO KNOWN AS CORNER NUMBER ONE:

THENCE <u>south 750 feet</u>	TO THE <u>E</u> SIDE CENTER
THENCE <u>south 750 feet</u>	TO CORNER NUMBER TWO;
THENCE <u>west 600 feet</u>	TO CORNER NUMBER THREE;
THENCE <u>north 750 feet</u>	TO THE <u>W</u> SIDE CENTER
THENCE <u>north 750 feet</u>	TO CORNER NUMBER FOUR;
THENCE <u>east 600 feet</u>	TO THE POINT OF BEGINNING

All monuments consist of 4" by 4", PVC posts at least 4 1/2 feet in length, and set in a mound of stones where such stones are available. All monuments are marked in a permanent manner so as to identify the monuments.

This claim is contiguous to, and bounded by the following claims:

TWIN <u>79</u>	on the North.
TWIN <u>57</u>	on the South.
TWIN <u>50</u>	on the West.
TWIN <u>57</u>	on the East.
