CERTIFICATE OF LOCATION  
LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has caused to be located the PROSPECTIVE 54 lode mining claim in the following quarter sections: NE $\frac{1}{4}$  and SE $\frac{1}{4}$ , of Section 23, Township 36 North, Range 49 East, M.D.B.&M., in the Lynn Mining District, in Eureka County, in the State of Nevada, on the 6th day of November, 1984.

The Claim is 1,450 feet long and 550 feet wide, such that 1,440 feet is claimed in a northerly direction and 10 feet in a southerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 275 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from a northerly to a southerly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 17th day of November, 1984.
