had come into Petitioner's knowledge or possession. The
Appraisement and Record of Value has been dispensed with by Order
of this Court;

4. The Order for Summary Administration dispensed with
all regular proceedings, including the Account of Personal
Representative;

1 5. All debts of the Decedent and liabilities of this
2 Estate, the expenses of administration thus far incurred, and all
3 taxes that have accrued against the Estate, have been paid and
4 discharged except: None.

5 6. The Estate is in a condition to be closed and final
6 distribution made to the persons legally entitled thereto as
7 hereinbelow provided;

8 7. The attorneys for the Petitioner are entitled to
9 reasonable compensation for their services and reimbursement of
10 their costs advanced from the Estate funds remaining in the hands
11 of the Petitioner as provided in the Petition for Approval of
12 Agreement on Attorney's Fees filed coincidentally herewith;

13 8. Petitioner has hereby waived the entitlement to the
14 allowance and payment of a statutory commission for her services
15 as Personal Representative;

16 9. The funds and other property of the Estate
17 remaining in the hands of Petitioner and available for payment of
18 unpaid costs of administration, including attorney's fees and
19 costs and Personal Representative's commission, and available for
20 distribution to the persons legally entitled thereto, was in part
21 community property and in part Decedent's separate property, and
22 consists of the following:

24 10. By the terms of the Last Will and Testament of
25 Decedent admitted to probate herein, the following persons are
26 entitled to distribution from the Estate of the following
