The Claim is 1,450 feet long and 550 feet wide, such that 725 feet is claimed in a northerly direction and 725 feet in a southerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 275 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from a northerly to a southerly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 18th day of December, 1984.

As erected on the ground, each boundary or corner monument is marked as described above by aluminum tags.

The location work consisted of making a claim map as provided in N.R.S. 517.040.
