

CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, THAT David A. Schaaf, P. O. Box 631, Delta, Colorado 81416, the undersigned, hereby locates the NESSA 449 Lode Mining Claim on the 2 day of November 1984, situated in the Unknown Mining District, Eureka County, Nevada, and by this certificate, and by right of discovery and location, claim 1500 feet, linear and horizontal measurement along the vein thereof, said vein running 25 feet in a North direction from the point of discovery and 1475 feet in a South direction from the point of discovery, together with 300 feet on either side of the middle of said vein at the surface. The discovery monument on which notice of this claim is posted is located at said point of which notice of this claim is posted is located at said point of discovery.

The general course of this lode or vein is North and South.

750 feet to the thence North a distance of West_Side Center;

thence North a distance of 750 feet to the NW Corner 4 which is a 4" OD, 5' in length PVC pipe marked NW Corner No. 4; NW Corner No. thence East a distance of 600 feet to Corner No. 1, the point of beginning.
