CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, THAT David A. Schaaf, P. O. Box 631, Delta, Colorado 81416, the undersigned, hereby locates the NESSA 474 Lode Mining Claim on the 3 day of November, 1984, situated in the Unknown Mining District, Eureka County, Nevada, and by this certificate, and by right of discovery and location, claim 1500 feet, linear and horizontal measurement along the vein thereof, said vein running 25 feet in a South direction from the point of discovery and 1475 feet in a North direction from the point of discovery, together with 300 feet on either side of the middle of said vein at the surface. The discovery monument on which notice of this claim is posted is located at said point of discovery.

The general course of this lode or vein is North and South.

Said Claim is located in the SE $\frac{1}{4}$  of Section 8, SW $\frac{1}{4}$  of Section 9, NW $\frac{1}{4}$  of Section 16 and NE $\frac{1}{4}$  of Section 17, Township 21 North, Range 51 East, Mount Diablo Meridian, Eureka County, State of Nevada, and more particularly described by metes and bounds as follows, to wit:

Beginning at the NE Corner No. 1 of this claim which is a 4" OD, 5' in length PVC pipe marked NE Corner No. 1,  
thence South a distance of 750 feet to the East Side Center;  
thence South a distance of 750 feet to the SE Corner No. 2 of this claim which is a 4" OD, 5' in length PVC pipe marked SE Corner No. 2;  
thence West a distance of 600 feet to the SW Corner No. 3 of this claim which is a 4" OD, 5' in length PVC pipe marked SW Corner No. 3;  
thence North a distance of 750 feet to the West Side Center;  
thence North a distance of 750 feet to the NW Corner No. 4 which is a 4" OD, 5' in length PVC pipe marked NW Corner No. 4;  
thence East a distance of 600 feet to Corner No. 1, the point of beginning.

Beginning at Corner No. 1 which is the Northeast corner of this claim, thence a distance of 15,000 feet North and 5400 feet West to the following natural object or permanent monument, to-wit; the Southwest Corner, Section 29, Township 22 North, Range 51 East, Mount Diablo Meridian.
