

CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, THAT David A. Schaaf, P. O. Box 631, Delta, Colorado 81416, the undersigned, hereby locates the NESSA 511 Lode Mining Claim on the 1984, situated in the Unknown Mining District, Eureka County, 1984, situated in the <u>Unknown Mining District</u>, <u>Eureka County</u>, Nevada, and by this certificate, and by right of discovery and location, claim <u>1500</u> feet, linear and horizontal measurement along the vein thereof, said vein running <u>25</u> feet in a <u>East</u> direction from the point of discovery and <u>1475</u> feet in a <u>West</u> direction from the point of discovery together with <u>2000</u> forther from the point of discovery, together with 300 feet on either side of the middle of said vein at the surface.
