THAT, the undersigned does hereby declare all its rights, under said oil and gas leases relinquished.

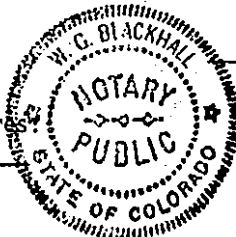
