The Claim is 1200 feet long and 250 feet wide, such that 10 feet is claimed in a Southeast direction and 1190 feet in a Northwest direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 125 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the northwest to the southeast direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 10th day of December, 19 84.
