CERTIFICATE OF LOCATION - MILL SITE - NEVADA

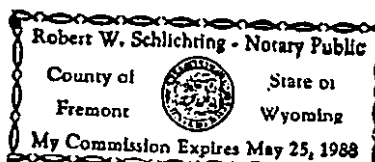
