PHILLIPS OIL COMPANY, a Delaware corporation, with offices in Houston, Texas (hereinafter referred to as "Assignor"), for and in consideration of Ten Dollars (\$10.00) and other valuable consideration and subject to the terms and conditions hereinafter stated, does hereby grant, bargain, sell, transfer and assign unto PHILLIPS PETROLEUM COMPANY, a Delaware corporation, with an operating office at Bartlesville, Oklahoma (hereinafter referred to as "Assignee"), all of Assignor's right, title and interest of whatever kind and character (including but not limited to any working interest, overriding royalty interest, and net profits interest) in and to (a) those certain oil, gas and mineral leases (hereinafter referred to as "leaseholds") more specifically described in Exhibit "A", attached hereto and expressly made a part hereof, together with all rights, privileges and estates given, created and granted thereunder; (b) all leasehold equipment, machinery, buildings, structures, pipelines, personal property, materials, and supplies located therein, thereon, or appurtenant thereto, including on or off-lease gathering lines, rights of way and other property associated therewith; and (c) all of the rights of Assignor in or under any contract, agreement, division order, license, permit, franchise, certificate, order, easement, and right of way concerning or associated with any such leasehold.

This Assignment is made and accepted upon the following terms and conditions:

1. This Assignment is made without warranty of title, express or implied, and is subject to all validly existing encumbrances or agreements which may affect said leaseholds.

2. ASSIGNOR DOES NOT WARRANT, EITHER EXPRESSLY OR IMPLIEDLY, THE MERCHANTABILITY, CONDITION OR FITNESS FOR ANY PARTICULAR PURPOSE OR USE OF ANY OF THE AFORESAID LEASEHOLD EQUIPMENT, MATERIAL OR PERSONAL PROPERTY DESCRIBED IN SUBPARAGRAPH (b) ABOVE, ANY SUCH WARRANTY BEING HEREBY EXPRESSLY NEGATED AND DENIED; AND ASSIGNEE AGREES TO ACCEPT THE SAME "AS IS" AND "WHERE IS".

3. The effective date of this Assignment shall be at 7:00 a.m. local time on April 1, 1985, regardless of the date of execution. All revenues, profits, losses and/or liabilities accruing through or resulting from the ownership, operations, utilizations or existence of, under, or in any way

related to the subject leaseholds, which are conveyed, assigned or transferred under or pursuant to the terms hereof and which are incurred or accrue before such date shall accrue to, be retained by or assumed by Assignor. 5. The terms and provisions hereof shall be deemed to be covenants running with the leaseholds hereinabove referred to and as such shall extend to, bind and inure to the benefit of the parties hereto, their successors and assigns.

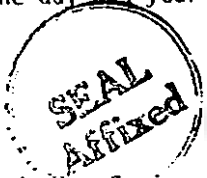
