GRANT, BARGAIN AND SALE DEED

W I T N E S S E T H:

That the said first party, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, and other good and valuable consideration to him in hand paid by the said second parties, receipt whereof is hereby acknowledged, does, by these presents grant, bargain, sell and convey unto the said second parties as joint tenants with right of survivorship and not as tenants in common, and to their assigns, and to the survivor of them, and to the heirs and assigns of the survivor, forever, all that certain real property situate in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

TOWNSHIP 29 NORTH, RANGE 51 EAST, M.D.B.&M.

Section 35: E4SE4

EXCEPTING THEREFROM all petroleum, oil, natural gas, and products derived therefrom, within or underlying said land, or that may be produced therefrom, as reserved in deed from Southern Pacific Land Company, dated January 17, 1950, recorded March 9, 1950, in Book 24, Page 42, Deed Records, Eureka County, Nevada.

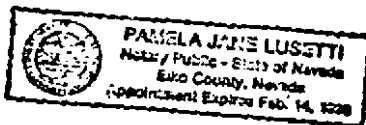
