## GRANT, BARGAIN AND SALE DEED

A portion of Lot 1, Block 10 of Crescent Valley Ranch and Farms, Unit 1, as designated on the plat thereof recorded in the County of Eureka, State of Nevada, on the 6th day of April, A.D. 1959, more particularly described as follows:
