QUITCLAIM DEED

#### I DEFINITIONS

- 5. "Subject Interests" means all of Grantor's right, title and interest of every kind or description, whether real, personal, or mixed in, to, or under the Subject Lands or in, to or under the Subject Leases.
- Effective Time means December 31, 1984 at 6:00 o'clock p.m. (Central Standard Time).
- 7. "Agreement and Instrument of Transfer" means that certain Agreement and Instrument of Transfer between Grantor and Grantee made as of 6:00 o'clock p.m. (Central Standard Time) on December 31, 1984.

For a valuable consideration as set forth in the Agreement and Instrument of Transfer, the receipt and sufficiency of which is hereby acknowledged, Grantor has sold and quitclaimed to Grantee the Subject Interests as of the Effective Time, and does hereby sell and quitclaim to Grantee the Subject Interests as of the Effective Time, and Grantee, its successors and assigns, shall have and hold the Subject Interests forever and neither Grantor nor its successors and assigns shall have, claim, or demand any right, title, or interest to the Subject Interests or any part thereof.

The purpose of this Quitclaim Deed is to implement the Agreement and Instrument of Transfer as required by the further assurances clause of such agreement. The Agreement and Instrument of Transfer shall remain in full force and effect after the execution of this Quitclaim Deed.

#### SAVINGS CLAUSE

To the extent that this Quitclaim Deed from Grantor to Grantee requires the consent or approval of any other person, partnership, corporation, or other legal entity or governmental body, the Effective Time shall be inapplicable until such consent or approval has been obtained, and upon the receipt of such consent or approval, this Quitclaim Deed shall be deemed to have commenced as of the Effective Date to the extend permitted by law.
