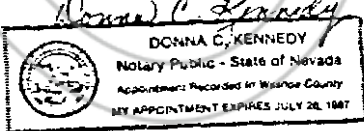

8 individually, on the First Claim for Relief of plaintiff's
9 complaint in the principal amount of TWO HUNDRED THIRTY-FIVE
10 THOUSAND DOLLARS (\$235,000.00), together with interest thereon
11 from September 30, 1983 to April 30, 1985, with interest thereon
12 from September 30, 1983 to April 30, 1985, in the amount of
13 SIXTY-THREE THOUSAND THREE HUNDRED SEVENTY-SIX DOLLARS and
14 FORTY-FIVE CENTS (\$63,376.45).

15 2. That judgment is hereby entered in favor of the
16 plaintiff, SECURITY BANK OF NEVADA, and against the defendants,
17 AMERICAN INVESTORS MANAGEMENT, INC., and LEWIS W. SHUMAN and
18 RUSSELL E. PINCHING, individually on the Fourth Claim for Relief
19 of plaintiff's complaint in the principal sum of ONE HUNDRED
20 THREE THOUSAND FIVE HUNDRED DOLLARS (\$103,500.00), together
21 with interest thereon from May 8, 1984 to April 30, 1985, in
22 the amount of SEVENTEEN THOUSAND FIVE HUNDRED FOURTEEN DOLLARS
23 and EIGHTY-NINE CENTS (\$17,514.89).

24 3. That defendant's Counterclaim be, and the same hereby
25 is, dismissed with prejudice.

26 4. That judgment is hereby entered in favor of the

1 plaintiff, SECURITY BANK OF NEVADA, and against the defendants,
2 AMERICAN INVESTORS MANAGEMENT, INC., and LEWIS W. SHUMAN and
3 RUSSELL E. PINCHING, individually, for plaintiff's reasonable
4 attorneys' fees in the amount of FIFTEEN THOUSAND DOLLARS
5 (\$15,000.00) together with costs of collection in accordance
6 with the Memorandum of Costs and Disbursements to be filed
7 herein by the plaintiff,
