NW/4 of Sec. \_\_\_\_\_  
SW/4 of Sec. 16

To tie this claim to the Public Survey, begin at the southeast corner of Section  
1, Township 23 North, Range 49 East, Mount Diablo Meridian, thence  
EAST 1500' THENCE NORTH 1500'  
to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing  
ledge, lode or vein, extending 1480 feet from the location monument in a  
northerly direction and 20 feet in a southerly  
direction, together with 300 feet on each side of the center of the ledge for  
the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5" PVC pipe  
or wooden post not less than 4"x4"x4' monuments firmly set in the ground bearing applicable  
designation. The description of such claim is: Beginning at Corner No.1, the Northeast  
Corner; thence,

South 750' to the east side center, a 4" x 5' PVC PIPE, thence,  
South 750' to the southeast corner, a 4" x 5' PVC PIPE, thence,  
West 600' to the southwest corner, a 4" x 5' PVC PIPE, thence,  
North 750' to the west side center, a WOOD POST AT LEAST 4" x 4" x 5', thence,  
North 750' to the northwest corner, a WOOD POST AT LEAST 4" x 4" x 5', thence,  
East 600' to the northeast corner, a WOOD POST AT LEAST 4" x 4" x 5', the point  
and place of beginning.

The monumentation and marking of the corners was completed by the 7th day of  
June, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two  
copies of this claim map have been filed with the Eureka County Recorder, and  
the lode claim filing fee has been paid to the County Recorder.
