To tie this claim to the Public Survey, begin at the southeast corner of Section  
1, Township 23 North, Range 49 East, Mount Diablo Meridian, thence  
WEST 300' Thence NORTH 1500'  
 to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing  
 ledge, lode or vein, extending 1480 feet from the location monument in a  
northerly direction and 20 feet in a southerly  
 direction, together with 300 feet on each side of the center of the ledge for  
 the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5" PVC pipe  
 or wooden post not less than 4"x4"x4' monuments firmly set in the ground bearing applicable  
 designation. The description of such claim is: Beginning at Corner No. 1, the Northeast  
 Corner; thence,

South 750' to the east side center, a 4"x5" PVC pipe, thence,  
 South 750' to the southeast corner, a 4"x5" PVC pipe, thence,  
 West, 600' to the southwest corner, a WOOD POST 4"x4"x4', thence,  
 North 750' to the west side center, a 4"x5" PVC pipe, thence,  
 North 750' to the northwest corner, a 4"x5" PVC pipe, thence,  
 East 600' to the northeast corner, a 4"x5" PVC pipe, the point  
 and place of beginning.

The monumentation and marking of the corners was completed by the 6th day of  
 June, 1985.
