direction, together with 300 feet on each side of the center of the ledge for

East 600' to the northeast corner, a 4"x5" PVC PIPE, the point
and place of beginning.

The monumentation and marking of the corners was completed by the 7th day of
June, 1985.

the lode claim filing fee has been paid to the County Recorder.
