direction, together with 300 feet on each side of the center of the ledge for
the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5' PVC pipe
or wooden post not less than 4"x4"x4' monuments firmly set in the ground bearing applicable
