We (or I) claim 1500 linear feet along the course of the mineral-bearing  
ledge, lode or vein, extending 1400 feet from the location monument in a  
northerly direction and 20 feet in a southerly  
direction, together with 300 feet on each side of the center of the ledge for  
the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5' PVC pipe
