West 5100' Thence North 7500'
 to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing
 ledge, lode or vein, extending 1480 feet from the location monument in a
northerly direction and 20 feet in a southerly
 direction, together with 875 feet on each side of the center of the ledge for
 the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5" PVC pipe
 or wooden post not less than 4"x4" monuments firmly set in the ground bearing applicable
 designation. The description of such claim is: Beginning at Corner No. 1, the Northeast
