Said claim is located in the NE/4 of Sec. 1,

NW/4 of Sec. 1  
SW/4 of Sec. 1

To tie this claim to the Public Survey, begin at the southeast corner of Section  
1, Township 23 North, Range 49 East, Mount Diablo Meridian, thence  
WEST 2400' HIGHER NORTH 8700'  
to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing  
ledge, lode or vein, extending 1480 feet from the location monument in a  
WESTERLY direction and 20 feet in a EASTERLY  
direction, together with 300 feet on each side of the center of the ledge for  
the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 4"x5" PVC pipe  
or wooden post not less than 4"x4"x4" monuments firmly set in the ground bearing applicable  
designation. The description of such claim is: Beginning at Corner No. 1, the Northeast  
Corner; thence,

South 600' to the SOUTHWEST CORNER, a 4"x5" PVC PIPE, thence,  
WEST 750' to the SOUTHWEST CORNER, a 4"x5" PVC PIPE, thence,  
West 750' to the southwest corner, a 4"x5" PVC PIPE, thence,  
North 600' to the NORTHWEST CORNER, a 4"x5" PVC PIPE, thence,
