The Claim is 1500 feet long and 600 feet wide, such that 50 feet is claimed in a NORTHERLY direction and 1450 feet in a SOUTHERLY direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 10 day of MAY, 1985.
