

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The claim is 1500 feet long and 200 feet wide, and 1480 feet is claimed in a southerly direction and 20 feet in a northerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 100 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the south to the north.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an inscribed aluminum tag.

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 4" diameter PVC post, Northeast Corner of R #45
- Corner No. 2 is a 4" diameter PVC post, East Side Center of R #45
- Corner No. 3 is a 4" diameter PVC post, Southeast Corner of R #45
- Corner No. 4 is a 4" diameter PVC post, Southwest Corner of R #45
- Corner No. 5 is a 4" diameter PVC post, West Side Center of R #45
- Corner No. 6 is a 4" diameter PVC post, Northwest Corner of R #45

The monumentation and marking of the corners was completed by the 1st day of July, 19 85.

(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
