CERTIFICATE OF LOCATION

The undersigned hereby certifies that he has caused to be located the POINT TOO lode mining claim in the following quarter sections: SE 1/4 of sec. 34 and SW 1/4 sec. 35, Township 34 North, Range 51 East; NE 1/4 sec. 3 and NW 1/4 sec. 2, Township 33 North, Range 51 East, M.D.B. & M., in the Maggie creek Mining District, in Eureka County, in the State of Nevada, on the 19th day of July, 1985.

The Claim is 1,375 feet long and 50 feet wide, such that 50 feet is claimed in a northerly direction and 1,325 feet in a southerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 25 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from a northerly to a southerly direction.

The definition of the boundaries of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 25th day of July, 1985.
