Commencing at the SE Corner which bears 300 feet Southerly and 850 feet Easterly from the location monument; thence Westerly 1300 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1300 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. Commencing at the SE Corner which bears 300 feet Southerly and 850 feet Easterly from the location monument; thence Westerly 1300 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1300 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 5405 feet in a N. 19° 20' E. direction from the SE Corner of Section 7, Township 34 North, Range 48 East, M.D.B. & M.
