

ESCROW AGREEMENT

THIS ESCROW AGREEMENT ("this Agreement") is made and entered into effective as of January 7, 1985, by and between Precambrian Exploration, Inc. ("PEX"), a Nevada corporation with an office and address for purposes of delivery and notice hereunder at 4955 Iris Street, Wheat Ridge, Colorado 80033, Precambrian, Inc. ("Shield"), a Nevada corporation with an office and address for purposes of notice and delivery hereunder at 1200 Trimac House, 800 5th Avenue, S.W., Calgary, Alberta, Canada T2P 3T6, and The First Interstate Bank of Denver, N.A. ("the Escrow Agent"), a national association with an office and address for purposes of delivery and notice hereunder to the attention of Mr. John G. Hudek at 633 Seventeenth Street, 2N053, Denver, Colorado 80270. For and in consideration of the mutual promises, conditions, and covenants which are set forth below, the adequacy as consideration whereof is hereby acknowledged by the parties, PEX, Shield, and the Escrow Agent agree as set forth in Articles I through VI of this Agreement.

ARTICLE I: DEFINITIONS AND RECITALS

1.1 Definitions. For purposes of this Agreement, terms defined in the Mining Lease shall have the meanings specified in Article I of the Mining Lease. In addition, the following terms shall have the meanings specified in this Section 1.1:

(a) "Amount Realized by Shield" shall mean a dollar amount calculated by adding the sum of all Royalty Payments to Shield to the aggregate Value of Products Taken by Shield as of the date of the calculation.

(b) "Assignment" shall mean that Assignment to Shield of a portion of PEX's rights and obligations under the Mining Lease which is attached hereto and incorporated herein as Exhibit I.

(c) "Escrowed Documents" shall mean and include the First Deed, the Reassignment, and the Second Deed.

(d) "First Deed" shall mean the original copy of the undated and incomplete but fully executed and acknowledged Deed (in the form attached hereto and incorporated herein as Exhibit II) from PEX to Shield which is placed in escrow hereunder.

(e) "Mining Lease" shall mean that certain Mining Lease between PEX and Tonkin Springs Gold Mining Company ("Tonkin Springs") which is dated effective as of January 5, 1985 and which was recorded in the official records of Eureka County, Nevada at 1:40 p.m. on

(f) "Notice of Lease Termination" shall mean a notice from PEx to Shield and the Escrow Agent which advises the Escrow Agent and Shield that the Mining Lease has expired or been terminated and specifies the date of termination.

(g) "Reassignment" shall mean the original copy of the undated but fully executed and acknowledged Reassignment (in the form attached hereto and incorporated herein as Exhibit III) from Shield to PEx of a portion of Shield's rights and obligations under the Mining Lease which is placed in escrow hereunder.

(h) "Rob Claims" shall mean the unpatented mining claims described in Exhibit A to the Assignment.

(i) "Royalty Payment to Shield" shall mean a mineral production royalty payment which Shield is entitled to receive under the Assignment and which is made to the Escrow Agent by Tonkin Springs and received by the Escrow Agent for the account of Shield as specified in this Agreement.

(j) "Second Deed" shall mean the original copy of the undated and incomplete but fully executed and acknowledged Deed (in the form attached hereto and incorporated herein as Exhibit IV) from Shield to PEx which is placed in escrow hereunder.

(k) "Value of Products Taken by Shield" shall mean the value in dollars (calculated as specified in Section 4.2 of this Agreement) of refined Products taken in kind or separately disposed of by Shield pursuant to its rights to do so under the Assignment and this Agreement.

1.2 Recitals. Under the Mining Lease, PEx leased the Rob Claims to Tonkin Springs. At present, the Rob Claims are the only real property subject to the Mining Lease, but the Mining Lease provides for an Area of Interest and therefore real property interests other than the Rob Claims may become subject to the Mining Lease in the future and be included within the Property as that term is defined in the Mining Lease. In the Assignment, PEx assigned to Shield 48.216% of PEx's rights and obligations as Lessor under the Mining Lease insofar (and only insofar) as such rights and obligations apply to the Rob Claims, including 48.216% of PEx's right to receive mineral production royalty payments and 48.216% of PEx's right to take in kind or separately dispose of refined Products under particular circumstances. Under Section 5.03 of the Mining Lease, Tonkin Springs must give notice at least ten (10) days prior to the time when refined Products will be available for taking in kind or separate disposition, so that the latter right can be properly

exercised. Under this Agreement, as soon as the Amount Realized by Shield is at least \$1,750,000.00, the Reassignment is to be delivered to PEX, so that Shield will thereafter have only 19.2864% of the rights and obligations of the Lessor with respect to the Rob Claims, and PEX will have the remaining 80.7136%. In addition, this Agreement sets forth the respective rights of PEX and Shield with regard to the Rob Claims if and when the Mining Lease is terminated or expires and provides for certain related eventualities.

ARTICLE II: ESCROW AGENT AND FEES

2.1 Escrow Agent. The Escrow Agent hereby acknowledges receipt of the Escrowed Documents and agrees to perform its obligations hereunder. Except as expressly provided to the contrary in this Agreement, the Escrow Agent shall not encumber or transfer, assign, or otherwise alienate or dispose of the Escrowed Documents.

2.2 Escrow Account. Each and every Royalty Payment to Shield shall be made by check from Tonkin Springs which is made payable to the Escrow Agent and shall be received by the Escrow Agent for the account of Shield as specified herein. An account (No. 6028987) in The First Interstate Bank of Denver, N.A., is hereby established to receive each such Royalty Payment to Shield from Tonkin Springs. The annual fee of the Escrow Agent for acting hereunder shall be \$2,000.00, and the Escrow Agent hereby acknowledges receipt from Shield of its annual fee for calendar year 1985. The Escrow Agent's annual fee shall be due and payable on or before the fifteenth (15th) day of January during each ensuing calendar year while this Agreement remains in full force and effect, and Shield shall pay the same. In the event that the Escrow Agent exercises its right to interplead the other parties hereto pursuant to the provisions of Section 4.10 of this Agreement, Shield shall reimburse the Escrow Agent for its reasonable legal fees paid or incurred in connection with the related action in the District Court for the City and County of Denver.

ARTICLE III: DUTIES OF PEX AND SHIELD

3.1 PEX's Specific Duties. In the event that the Mining Lease expires or is terminated for any reason, PEX shall thereupon send the Notice of Lease Termination to Shield and the Escrow Agent. Within one (1) full year after the date of termination or expiration of the Mining Lease, PEX shall give Shield and the Escrow Agent notice of the election by PEX to exercise one (1) of PEX's three (3) options under Section 5.1 of this Agreement. If PEX fails to give Shield and the Escrow Agent notice of PEX's election to exercise one (1) of its three (3) options under Section 5.1 hereof within the period of one (1) year required by this Section 3.1, then PEX shall be conclusively deemed to have elected to exercise the option described in Subsection 5.1(c) of this Agreement.

3.2 Shield's Specific Duties. If and each time that Shield exercises its right to take in kind or separately dispose of a portion of refined Products under the Assignment and the Mining Lease, Shield shall thereupon notify the Escrow Agent and PEX of the exercise of such right. Each such notice shall specify the date when the refined Products in question were available for taking (as determined by Tonkin Springs under Section 5.03 of the Mining Lease), the total amount of refined Products so taken or separately disposed of, the date of such taking or disposition, and any other information which may be required in order for the Escrow Agent to calculate the Value of Products Taken by Shield. In addition, if and when the First Deed is delivered to Shield by the Escrow Agent as provided herein, Shield shall record the First Deed in the real property records of Eureka County, Nevada, and shall notify PEX and the Escrow Agent of the date, book and pages, and file number of such recordation.

3.3 Limitation on Taking. Anything to the contrary in the Assignment or in this Agreement notwithstanding, if and when any individual exercise by Shield of its right to take in kind or separately dispose of a portion of refined Products from a shipment of refined Products then available for taking will cause the Amount Realized by Shield to exceed \$1,750,000.00, then Shield shall limit such individual taking or separate disposition to the amount of refined Products which will make the Amount Realized by Shield equal to \$1,750,000.00, plus 19.2864% of the remainder of that particular shipment of refined Products. PEX shall have the sole and exclusive right to take in kind or separately dispose of 80.7136% (100% less 19.2864%) of such remainder.

3.4 General Duties. In addition to the specific duties enumerated in this Article III, both PEX and Shield shall promptly perform such other duties hereunder as may be reasonably necessary in order to give full effect to the terms and provisions hereof.

ARTICLE IV: DUTIES OF ESCROW AGENT

4.1 Royalty Payments to Shield. Upon its receipt of each check from Tonkin Springs representing a Royalty Payment to Shield, the Escrow Agent shall make a permanent record of the amount thereof. Except as expressly provided to the contrary in Section 4.3 hereof, the Escrow Agent shall promptly forward each such check to Shield (properly endorsed for payment to Shield), and shall notify PEX of the amount so forwarded.

4.2 Calculation of Value. For purposes of this Agreement, the Value of Products Taken by Shield shall, in each case of such taking in kind or separate disposition, be calculated by reference to the afternoon London fixing price of refined gold bullion on the date when Tonkin Springs determined that such refined Products were

available for taking under Section 5.03 of the Mining Lease. Upon its receipt of each notice from Shield that Shield has exercised its right to take in kind or separately dispose of a portion of refined Products, the Escrow Agent shall calculate the Value of Products Taken by Shield and described in the notice and shall notify PEX and Shield thereof.

4.3 Division of Royalty Payment. If the forwarding to Shield of any individual Royalty Payment to Shield would cause the Amount Realized by Shield to exceed \$1,750,000.00, then the Escrow Agent shall divide that particular Royalty Payment to Shield between PEX and Shield. Shield shall be entitled to receive such portion thereof as will make the Amount Realized by Shield equal to \$1,750,000.00, plus 19.2864% of the remainder of that particular Royalty Payment to Shield. PEX shall be entitled to receive 80.7136% (100% less 19.2864%) of such remainder. To the extent that the provisions of Section 3.3 or 4.3 of this Agreement conflict with the terms and conditions of the Assignment, the provisions of Sections 3.3 and 4.3 hereof shall control in all respects.

4.4 Delivery to PEX of Reassignment. The Escrow Agent shall determine when the Amount Realized by Shield equals or exceeds \$1,750,000.00, and shall thereupon date and deliver the Reassignment to PEX and give notice of such delivery to Shield.

4.5 Delivery to Shield of First Deed. Upon its receipt of the Notice of Lease Termination from PEX, the Escrow Agent shall complete the First Deed by calculating and inserting therein the magnitude of the undivided interest in the Rob Claims thereby conveyed (rounded off to four decimal places), and shall date and deliver the First Deed to Shield and give PEX notice of such delivery. If the Mining Lease expired or was terminated before the Amount Realized by Shield reached \$1,750,000.00, then the magnitude of the undivided interest in the Rob Claims conveyed to Shield in the First Deed shall be calculated by adding 9.6432% (20% of 48.216%) to the product of 38.5728% (80% of 48.216%) multiplied by a fraction. The numerator of the fraction shall be \$1,750,000.00 minus the Amount Realized by Shield, and the denominator of the fraction shall be \$1,750,000.00. If the Mining Lease expired or was terminated after the Amount Realized by Shield reached \$1,750,000.00, then the magnitude of the undivided interest in the Rob Claims conveyed to Shield in the First Deed shall be 9.6432% (20% of 48.216%).

4.6 Delivery to Shield of Reassignment. When the First Deed is delivered to Shield by the Escrow Agent as specified in Section 4.5 hereof, if the Reassignment then remains in the possession of the Escrow Agent because the Mining Lease expired or was terminated before the Amount Realized by Shield reached \$1,750,000.00, then the Escrow Agent shall deliver the Reassignment to Shield

contemporaneously with its delivery of the First Deed to Shield and shall give notice to PEX of such delivery.

4.7 Delivery to PEX of Second Deed. Upon its receipt of a notice from PEX that PEX has elected to exercise the option described in Subsection 5.1(a) hereof which is accompanied by the certified or cashier's check from PEX to Shield referred to in Section 5.2 of this Agreement, the Escrow Agent shall date and complete the Second Deed (by inserting therein the effective date of the First Deed and its date, book and pages, and file number of recordation in Eureka County, Nevada) and shall deliver the Second Deed to PEX and the certified or cashier's check to Shield.

4.8 Delivery to Shield of Second Deed. If and when PEX elects or is deemed to have elected to exercise the option described in Subsection 5.1(b) or the option described in Section 5.1(c) hereof, then the Escrow Agent shall deliver the Second Deed to Shield and shall give notice of such delivery to PEX.

4.9 General Duties. In addition to the specific duties enumerated in Sections 4.1 through 4.8 above, the Escrow Agent shall promptly perform such other duties hereunder as may be reasonably necessary in order to give full effect to the terms and provisions hereof.

4.10 Terms of the Escrow Agent's Obligations. PEX and Shield jointly and severally indemnify and hold the Escrow Agent harmless from and against any loss, liability, claim, demand, suit, or action incurred by the Escrow Agent in connection with its capacity or duties hereunder, except in the case of the Escrow Agent's gross negligence, fraud, or intentional misconduct. In the event of any dispute with respect to the disposition of the Escrowed Documents, the Escrow Agent may (in its sole and absolute discretion) deposit the same or so much thereof as remains in its hands with the then Clerk, or acting Clerk, of the District Court for the City and County of Denver, State of Colorado, and interplead the other parties hereto, and upon so depositing the Escrowed Documents and filing its complaint in interpleader, it shall be relieved of all liabilities under the terms hereof as to the materials so deposited, and furthermore, the other parties hereto for themselves and their successors and assigns do hereby submit themselves to the jurisdiction of said court and do hereby appoint the then Clerk, or acting Clerk, of said court as their agent for the service of all process in connection with such proceedings. The institution of any such interpleader action shall not impair the rights of the Escrow Agent. The Escrow Agent is hereby expressly authorized to comply with and obey any and all orders, judgments, or decrees of any court, and in the event that the Escrow Agent obeys or complies with any such order, judgment, or decree of any court it shall not be liable to any of the parties or to any other person, firm, or corporation by reason of such

compliance, notwithstanding that any such order, judgment, or decree may be subsequently reversed, modified, annulled, set aside, or vacated, or may be found to have been entered without jurisdiction. The Escrow Agent may rely and shall be protected in relying upon written authorization, notice, request, or other instrument or document furnished to the Escrow Agent and reasonably believed by the Escrow Agent to be genuine and to have been signed or presented by the proper party, not only as to its due execution and the validity and effectiveness of its provisions, but also as to the truth and acceptability of any information therein contained which the Escrow Agent in good faith believes to be genuine and what it purports to be. The indemnification contained in this Section 4.10 shall survive any termination of this Agreement.

ARTICLE V: PEX'S OPTIONS

5.1 Exercise. For a period of one (1) full year after expiration or any termination of the Mining Lease, PEX may exercise one (1) of the following three (3) options by giving Shield and the Escrow Agent notice of PEX's election to do so:

(a) To purchase all of the undivided interest in the Rob Claims which Shield acquired by virtue of the First Deed for a total purchase price calculated by subtracting from \$2,187,500.00 the Amount Realized by Shield plus the amount of any net revenues otherwise realized by Shield after termination of the Mining Lease which were attributable to Shield's undivided ownership interest in the Rob Claims; or

(b) To make the entire undivided interest in the Rob Claims which Shield acquired by virtue of the First Deed subject to a mining lease between Shield as Lessor and PEX as Lessee under terms and conditions which are identical to the terms and conditions of the Mining Lease as of the date of execution of the Mining Lease, but with any deadlines therein for the performance of obligations by the Lessee which Tonkin Springs failed to meet extended for a period of one year after the date of PEX's notice to Shield and the Escrow Agent of its election to exercise the option described in this Subsection 5.1(b); or

(c) To make the entire undivided interest in the Rob Claims which Shield acquired by virtue of the First Deed subject to a joint venture between PEX and Shield with PEX as Manager, with the initial Participating Interests of PEX and Shield identical to their respective undivided interests in the Rob Claims, and with other basic terms and conditions identical to the Rocky Mountain Mineral Law Foundation Model Form Mining Venture Agreement (Form 5) published during 1984 and incorporated herein by this reference.

5.2 Purchase Price. In the event that PEx elects to exercise the option described in Subsection (a) of Section 5.1 hereof, PEx's notice thereof to the Escrow Agent shall be accompanied by a certified or cashier's check payable to Shield in the amount of the total purchase price of the undivided interest in the Rob Claims which Shield acquired by virtue of the First Deed.

5.3 Additional Documents. In the event that PEx elects or is deemed to have elected to exercise the option described in Subsection 5.1(b) or the option described in Subsection 5.1(c) hereof then, within thirty (30) days after the effective date of such election, PEx and Shield shall execute, acknowledge, and deliver the required mining lease or joint venture, as the case may be. In the event of any dispute whatsoever between PEx and Shield with regard to the execution of such joint venture or mining lease, such dispute shall be settled by arbitration in accordance with the Commercial Arbitration Rules of the American Arbitration Association, and judgment upon the award rendered by the Arbitrator(s) may be entered in any Court having jurisdiction thereof.

ARTICLE VI: GENERAL

6.1 Termination. This Agreement may be terminated at any time by mutual agreement between PEx and Shield. In addition, this Agreement shall terminate automatically, without further act by the parties or any of them, either upon proper disposition by the Escrow Agent of each of the Escrowed Documents as provided herein, or upon full compliance by PEx and Shield with any applicable terms and provisions of Section 5.3 hereof, whichever last occurs. Except as expressly provided to the contrary in this Section 6.1, none of the parties shall have any right whatsoever to terminate this Agreement.

6.2 Perpetuities. Any right or option to acquire any interest in real property under this Agreement must be exercised, if at all, so as to vest such interest in the acquirer within twenty-one (21) years after the effective date of this Agreement.

6.3 Dollar Amounts. All references to dollar amounts herein are references to the funds and currency of the United States of America.

6.4 Notice. All notices, payments, consents, or other communications required or permitted by terms of this Agreement shall be in writing and shall be either personally delivered or placed in the registered or certified mail, postage prepaid, return receipt requested, in either case addressed to the party to receive the communication at that party's address for purposes of delivery and notice as given in this Agreement. Communications personally delivered shall be deemed to have been given and received on the date of delivery, and communications so mailed shall be deemed to have

been given and received on the date of receipt indicated on the return receipt therefor. Any party may change its respective address for purposes of delivery and notice hereunder by giving the other parties notice of such change in the manner specified in this Section 6.4.

6.5 Modification. Subject only to the provisions of Section 6.6 hereof, this Agreement may not be modified, amended, extended, supplemented, or otherwise altered except by written instrument executed by an appropriate and authorized officer of each of the parties.

6.6 Choice of Law and Severability. The parties shall be subject to and the terms and provisions of this Agreement shall be construed under the internal laws of the State of Colorado, but not its rules regarding conflicts of laws. The individual provisions of this Agreement are severable. If any such individual provision is contrary to or in conflict with any requirement or principal of applicable statutory or common law, that provision and the remainder of this Agreement shall be construed so as to give effect to the intent of the parties.

6.7 Assignment. Except as expressly provided to the contrary in this Section 6.7, none of the parties shall have either the right or the power to assign or shall assign all or any portion of their respective rights or duties hereunder without the prior consent of each of the other parties (which consent shall not be unreasonably withheld) and any assignment made without such consent shall be void. The foregoing requirement for prior consent shall not apply to any assignment by PEx to an Affiliate of PEx. The terms and provisions hereof shall be binding upon, inure to the benefit of, and be fully enforceable by the respective successors and permitted assigns of the parties.

6.8 Further Assurances. Each of the parties agrees to take such corporate actions and to obtain and to execute, acknowledge, and deliver to the other parties such additional or further formal documents or instruments as may be reasonably necessary in order to give full effect to the terms and conditions of this Agreement including, without limitation, the terms and conditions of Article V hereof.

6.9 Sole Agreement. Excepting only the Assignment, as of the effective date hereof, this Agreement is the sole agreement between the parties or any of them with respect to the subject matter hereof, all prior agreements between the parties or any of them with respect to the subject matter hereof (if any) being expressly rescinded and replaced hereby. Excepting only the Assignment, no prior or contemporaneous oral or written agreements of any nature whatsoever with respect to the subject matter hereof shall be binding upon the parties.

ASSIGNMENT AND AGREEMENT

THIS ASSIGNMENT AND AGREEMENT ("this Assignment") is made and entered into effective as of January 6, 1985, by and between Precambrian Exploration, Inc. ("PEX"), a Nevada corporation with an office and address for purposes of delivery and notice hereunder at 4955 Iris Street, Wheat Ridge, Colorado 80033, and Precambrian, Inc. ("Shield"), a Nevada corporation with an address for purposes of delivery and notice hereunder at 1200 Trimac House, 800 5th Avenue, S.W., Calgary, Alberta, Canada T2P 3T6.

1. Definitions. For purposes of this Assignment, terms which are defined in the Mining Lease shall have the meanings specified in Article I of the Mining Lease. In addition, the following terms shall have the meanings specified in this Paragraph 1:

(a) "Mining Lease" shall mean that certain Mining Lease between PEX and Tonkin Springs Gold Mining Company ("Tonkin Springs") which is dated effective as of January 5, 1985 and which was recorded in the official records of Eureka County, Nevada at 1:40 p.m. on July 5, 1985 at Book 137, Pages 082-140 (inclusive) under File No. 99737.

(b) "Rob Claims" shall mean the unpatented mining claims described in Exhibit A to this Assignment.

2. Recitals. PEX leased the Rob Claims to Tonkin Springs under the Mining Lease. At present, the Rob Claims are the only real property subject to the Mining Lease, but the Mining Lease provides for an Area of Interest and therefore real property interests other than the Rob Claims may become subject to the Mining Lease in the future and be included within the Property as that term is defined in the Mining Lease. Under Section 9.01 of the Mining Lease, PEX has the right to freely assign all or any portion of its rights and obligations under the Mining Lease to Precambrian Shield Resources Limited, an Alberta Corporation, or to any Affiliate of Precambrian Shield Resources Limited. Shield is a wholly-owned subsidiary of Precambrian Shield Resources Limited and therefore an Affiliate of Precambrian Shield Resources Limited within the meaning of the Mining Lease. Shield desires to obtain an assignment of a portion of PEX's rights and obligations under the Mining Lease insofar as such rights and obligations apply to the Rob Claims, and PEX is willing to make such an assignment, subject to the terms and provisions hereof. For and in consideration of the sum of One or more Dollars exchanged by PEX and Shield and in consideration of the mutual promises, conditions, and covenants set forth below, the receipt and adequacy as consideration whereof is hereby acknowledged by the parties, PEX

and Shield agree as set forth in Paragraphs 1 through 16 of this Assignment.

3. Assignment. Subject to the terms and provisions of Paragraph 4 hereof, PEx hereby assigns 48.216% of each of its rights and obligations under the Mining Lease to Shield insofar (and only insofar) as such rights and obligations apply to the Rob Claims including, without limitation:

(a) The right to receive mineral production royalty payments under Section 5.02 of the Mining Lease;

(b) The right to receive mineral production royalty payments under Section 5.03 of the Mining Lease;

(c) The right to receive mineral production royalty payments under Section 5.04 of the Mining Lease;

(d) The right to take in kind or separately dispose of refined Products, as specified in and subject to the conditions and limitations of Section 5.03 of the Mining Lease;

(e) The obligation to pay any extra expenditure incurred by Tonkin Springs due to taking in kind or separate disposition of refined Products, as required by Section 5.03 of the Mining Lease; and

(f) The obligation to pay the Costs of Mining and Commercial Production that are associated with the production of refined Products taken in kind or separately disposed of, as required by Section 5.03 of the Mining Lease.

It is recognized and acknowledged by the parties that the percentage of Net Profits which is payable to the Lessor as mineral production royalty under the Mining Lease is variable, and that Shield's right to receive a mineral production royalty payment at any particular time is limited to receiving 48.216% of the total mineral production royalty payment which is payable to the Lessor under the Mining Lease at the time in question. For instance, when the Lessor is entitled to a mineral production royalty payment equal to 10% of Net Profits under Section 5.02 or 5.04 of the Mining Lease, Shield shall be entitled to receive 4.8216% (48.216% of 10%) of that payment. Likewise, when the Lessor is entitled to a mineral production royalty payment equal to 70% of Net Profits under Section 5.02 of the Mining Lease, Shield shall be entitled to receive 33.7512% (48.216% of 70%) of that payment. Accordingly, when the Lessor is entitled to a mineral production royalty payment equal to 45% of Net Profits under Section 5.03 of the Mining Lease, Shield shall be entitled to receive 21.6972% (48.216% of 45%) of that payment. When the Lessor is entitled to take in kind or separately dispose of 45%

of refined Products under Section 5.03 of the Mining Lease, Shield shall be entitled to take in kind or separately dispose of 21.6972% (48.216% of 45%) of such refined Products, and shall be obligated to pay 21.6972% of the Costs of Mining and Commercial Production that are associated with the production of refined Products so taken or disposed of by Shield and 100% of any extra expenditure incurred by Tonkin Springs due to such taking in kind or separate disposition.

4. Retention of Rights and Obligations by PEx. Anything to the contrary in this Assignment notwithstanding, it is understood and agreed by the parties that:

(a) Except as expressly provided to the contrary in this Paragraph 4, PEx has and is retaining 51.784% (100% less 48.216%) of each and every right and obligation of the Lessor under the Mining Lease including, without limitation, the rights and obligations specifically referred to in Paragraph 3 of this Assignment;

(b) Shield shall not be entitled any portion of any payment which Tonkin Springs is required to make to the Lessor under either or both Sections 4.02 and 4.03 of the Mining Lease (all rights to receive such payments are retained by PEx, all such payments shall be made exclusively to PEx, and PEx shall have and receive the same free and clear of the terms and provisions of this Assignment);

(c) PEx has and retains the sole and exclusive right to give the Lessor's consent to and approval of any title curative or other actions proposed by Tonkin Springs as specified in Section 6.04 of the Mining Lease;

(d) PEx has and retains the sole and exclusive right to give the Lessor's consent to and approval of any acquisitions of interests in real property within the Area of Interest which are proposed as specified in Section 8.01 of the Mining lease;

(e) PEx has and retains 100% of all rights and obligations of the Lessor under Section 9.02 of the Mining Lease;

(f) Subject only to the provisions of this Paragraph 4, PEx has and retains the sole and exclusive right to terminate the Mining Lease under any conditions which permit such termination and has and retains the sole and exclusive right to exercise the rights and remedies of the Lessor under Section 10.01 and Article XI of the Mining Lease; and

(g) PEx has and retains 100% of all rights and obligations of the Lessor under the Mining Lease with respect to each and every Property other than the Rob Claims including, without limitation, the right to receive 100% of each mineral production royalty payment generated by minerals mined from such a Property, the obligation to

pay 100% of the Costs of Mining and Commercial Production that are associated with the production of refined Products mined from such a Property and taken in kind or separately disposed of by PEX, and the obligation to pay 100% of any extra expenditure incurred by Tonkin Springs due to such taking in kind or separate disposition by PEX.

Shield may invoke the rights and remedies of the Lessor under Subsection 10.01(3) and Article XI of the Mining Lease if, and only if, PEX has received all mineral production royalty payments from Tonkin Springs which PEX is entitled to receive pursuant to the Mining Lease and this Assignment but Tonkin Springs has defaulted in making a mineral production royalty payment to Shield which Shield is entitled to receive by virtue of the terms and conditions hereof. Except as expressly provided to the contrary in the immediately preceding sentence, nothing in this Assignment is intended to or shall ever be construed or applied so as to give Shield the right to terminate the Mining Lease, in whole or in part, or to participate in any way in any decision by PEX to terminate the Mining Lease or to exercise or forego the exercise of the rights and remedies of the Lessor under Section 10.01 or Article XI of the Mining Lease.

5. Compliance by Shield. As required by Sections 9.01(a) and 9.03 of the Mining Lease, Shield agrees to assume and perform the obligations of the Lessor under the Mining Lease insofar as such obligations apply to the Rob Claims and to the extent (48.216%) that such obligations are assigned to Shield herein including, without limitation, the obligations specifically referred to in Subparagraphs (e) and (f) of Paragraph 3 of this Assignment and the obligations imposed upon the Lessor by Section 12.08 of the Mining Lease. Shield agrees to and hereby indemnifies, protects, saves, and holds PEX harmless from and against any and all losses, costs, expenses, attorneys' fees, claims, demands, liabilities, suits, and actions of every kind and character arising directly or indirectly from or in any way related to any failure by Shield to perform its appropriate share of such obligations. Without waiver of any remedy otherwise available to PEX, if Shield fails or refuses to make prompt and timely payment of any amount which Shield is obligated to pay to Tonkin Springs under the Mining Lease and this Assignment, then PEX shall have the right to pay or otherwise discharge such amount and to recover the same as specified in this Paragraph 5. At its option and election, PEX may pay or discharge any such amount on behalf of Shield and may treat the same, together with any accrued interest, as a demand loan to Shield bearing interest from the date of the advance at the Prime Interest Rate. Shield hereby grants to PEX a lien upon and a security interest in its rights under the Mining Lease and this Assignment, and all proceeds therefrom, to secure any loan so made by PEX hereunder, including interest thereon, reasonable attorneys' fees, and all other reasonable costs and expenses paid or incurred by PEX in recovering the loan with interest and in enforcing such lien or security interest, or both. In addition to its rights and

remedies set forth in this Paragraph 5, PEx shall have all other available legal and equitable rights or remedies permitted by or provided for under applicable law. Shield hereby irrevocably appoints PEx as Shield's attorney-in-fact to execute, file, and record all instruments necessary to perfect or effectuate the provisions hereof. The indemnification contained in this Paragraph 5 shall survive any termination of this Assignment.

6. Subordination. If any transfer by Shield hereunder of an interest in this Assignment or in the Mining Lease rights or obligations acquired by Shield hereunder is the grant of a security interest by pledge, lien, or other encumbrance of any interest in this Assignment or in the Mining Lease, or any proceeds therefrom, to secure a loan or other indebtedness of Shield in a bona fide transaction or for any other purpose, such security interest shall be subordinate to the terms of this Assignment and the Mining Lease and the rights and interests of the parties thereto. Upon any foreclosure or other enforcement of rights in the security interest, the acquiring third party shall be deemed to have assumed the position of Shield with respect to this Assignment and the Mining Lease. If a sale or other commitment or disposition of Products or proceeds from the sale of Products by Shield in anticipation of distribution thereof creates in a third party a security interest in Products or proceeds therefrom prior to such distribution, such sales, commitment, or disposition shall be subject and subordinate to the terms and conditions of this Assignment and the Mining Lease.

7. Special Warranty by PEx. PEx represents and warrants to Shield that, prior to the effective date of this Assignment, PEx has not assigned the rights and obligations which are assigned to Shield herein to any person or entity other than Shield, and that the rights and obligations assigned to Shield herein are, as of the effective date of this Assignment, free from encumbrances made or suffered by PEx or made or suffered by any person or entity claiming under PEx.

8. Rounding Off. For purposes of dividing mineral production royalties between PEx and Shield or of assessing any appropriate charges or costs hereunder, it is agreed that Tonkin Springs may round amounts ending in a fraction of a dollar equal to or exceeding Fifty Cents (\$0.50) up to the next whole dollar, and amounts ending in a fraction of a dollar less than Fifty Cents (\$0.50) down to the next whole dollar.

9. Termination. This Assignment may be terminated by mutual agreement between PEx and Shield, and shall terminate automatically, without further act by the parties or either of them, immediately upon termination or expiration of the Mining Lease. No termination hereof shall relieve or deprive either of the parties of or from any right or obligation which attaches or accrues prior to

the date of termination. Except as expressly provided to the contrary in this Paragraph 9, neither of the parties shall have any right whatsoever to terminate this Assignment.

10. Notice. All notices or other communications required or permitted by the terms of this Assignment shall be in writing and shall be either personally delivered or placed in the registered or certified mail, postage prepaid, return receipt requested, in either case addressed to the party to receive the communication at that party's address for purposes of delivery and notice as given in this Assignment. Communications personally delivered shall be deemed to have been given and received on the date of delivery, and communications so mailed shall be deemed to have been given and received on the date of receipt indicated on the return receipt therefor. Either of the parties may change its respective address for purposes of delivery and notice hereunder by giving the other party notice of such change in the manner specified in this Paragraph 10.

11. Modification. Subject only to the provisions of Paragraph 12 hereof, this Assignment may not be modified, amended, extended, supplemented, or otherwise altered except by written instrument executed by an appropriate and authorized officer or officers of each of the parties.

12. Choice of Law and Severability. The parties shall be subject to and the terms and provisions of this Assignment shall be construed under the internal laws of the State of Nevada, but not its rules regarding conflicts of laws. The individual provisions of this Assignment are severable. If any such individual provision is contrary to or in conflict with any requirement or principal of applicable statutory or common law, that provision and the remainder of this Assignment shall be construed so as to give effect to the intent of the parties.

13. Remedies Cumulative. All remedies of the parties hereunder shall be cumulative, and not exclusive. The election of one or more remedies shall not waive the election of any other remedies.

14. Assignment. No assignment of any interest in this Assignment or in the Mining Lease rights or obligations acquired by Shield hereunder shall require Tonkin Springs to divide any payment to be made to Shield hereunder into fractional or aliquot portions, Shield agreeing on behalf of itself and its successors and assigns that any such payment shall be made by a single check payable to Shield or Shield's designee bank and to be divided by Shield or Shield's designee bank among Shield and its successors and assigns into such portions as may be appropriate. Subject to the terms and provisions hereof, each of the parties shall have the right and the power to freely assign all or any portion of its respective rights

and obligations hereunder. The terms and provisions hereof shall be binding upon, inure to the benefit of, and be fully enforceable by the respective successors and assigns of the parties.

15. Further Assurances. Each of the parties agrees to take such corporate actions and to obtain and to execute, acknowledge and deliver to the other party such additional or further formal documents or instruments as may be reasonably necessary in order to give full effect to the terms and conditions of this Assignment.

16. Sole Agreement. As of its effective date, this Assignment is the sole agreement between the parties with respect to the subject matter hereof, all prior agreements between the parties with respect to the subject matter hereof (if any) being expressly rescinded and replaced hereby. No prior or contemporaneous oral or written agreements of any nature whatsoever with respect to the subject matter hereof shall be binding upon the parties.

REASSIGNMENT AND MODIFICATION

THIS REASSIGNMENT AND MODIFICATION (This Reassignment") is made and entered into effective as of 1985, 1985, by and between Precambrian, Inc. ("Shield"), a Nevada corporation with an office and address at 1200 Trimac House, 800 5th Avenue, S.W., Calgary, Alberta, Canada T2P 3T6, and Precambrian Exploration, Inc. ("PEX"), a Nevada corporation with an office and address at 4955 Iris Street, Wheat Ridge, Colorado 80033.

1. Definitions. For purposes of this Reassignment, terms which are defined in the Mining Lease shall have the meanings specified in Article I of the Mining Lease. In addition, the following terms shall have the meanings specified in this Paragraph 1:

(a) "Assignment" shall mean that certain Assignment and Agreement between PEX and Shield dated effective as of January 6, 1985.

(b) "Mining Lease" shall mean that certain Mining Lease between PEX and Tonkin Springs Gold Mining Company ("Tonkin Springs") which is dated effective as of January 5, 1985 and which was recorded in the official records of Eureka County, Nevada at 1:40 p.m. on July 5, 1985 at Book 137, Pages 082-140 (inclusive) under File No. 99737.

(c) "Escrow Agreement" shall mean that certain escrow agreement between PEX, Shield, and The First Interstate Bank of Denver, N.A., which is dated effective as of January 7, 1985.

(d) "Rights and Obligations" shall mean the rights and obligations of the Lessor under the Mining Lease insofar, and only insofar, as such rights and obligations apply to the Rob Claims.

(e) "Rob Claims" shall mean the unpatented mining claims described in Attachment One to this Reassignment.

2. Recitals. PEX leased the Rob Claims to Tonkin Springs under the Mining Lease. As of the effective date of the Mining Lease, the Rob Claims were the only real property subject to the Mining Lease, but the Mining Lease provides for an Area of Interest and therefore real property interests other than the Rob Claims may now have or hereafter become subject to the Mining Lease and be included within the Property as that term is defined in the Mining Lease. In Paragraph 3 of the Assignment, PEX assigned to Shield 48.216% of the Rights and Obligations, with certain exceptions enumerated in Paragraph 4 of the Assignment. In Paragraph 4 of the

Assignment, PEx reserved 51.784% of each of the Rights and Obligations, and 100% of all rights and obligations of the Lessor under the Mining Lease with respect to each and every Property other than the Rob Claims. Under Section 9.01 of the Mining Lease, Shield has the right to freely reassign all or any portion of the Rights and Obligations to PEx. PEx desires to obtain a reassignment of a portion of the Rights and Obligations, and Shield is willing to make such a reassignment, subject to the terms and provisions hereof. For and in consideration of the sum of One or more Dollars exchanged by Shield and PEx and in consideration of the mutual promises, conditions, and covenants set forth below, the receipt and adequacy as consideration whereof is hereby acknowledged by the parties, Shield and PEx agree as set forth in Paragraphs 1 through 8 of this Reassignment.

3. Reassignment. Shield hereby reassigns 28.9296% (0.289296) of the Rights and Obligations to PEx including, without limitation:

(a) The right to receive mineral production royalty payments under Section 5.02 of the Mining Lease;

(b) The right to receive mineral production royalty payments under Section 5.03 of the Mining Lease;

(c) The right to receive mineral production royalty payments under Section 5.04 of the Mining Lease;

(d) The right to take in kind or separately dispose of refined Products, as specified in and subject to the conditions and limitations of Section 5.03 of the Mining Lease;

(e) The obligation to pay any extra expenditure incurred by Tonkin Springs due to taking in kind or separate disposition of refined Products, as required by Section 5.03 of the Mining Lease; and

(f) The obligation to pay the Costs of Mining and Commercial Production that are associated with the production of refined Products taken in kind or separately disposed of, as required by Section 5.03 of the Mining Lease.

As required by Sections 9.01(a) and 9.03 of the Mining Lease, PEx agrees to reassume and perform the Rights and Obligations to the extent (28.9296%) that the same are reassigned to PEx herein including, without limitation, the Rights and Obligations specifically referred to in this Paragraph 3.

4. Retention of Rights and Obligations by Shield. Anything to the contrary in this Reassignment notwithstanding, it is

understood and agreed by the parties that Shield has and is retaining 19.2864% (48.216% less 28.9296%) of the Rights and Obligations including, without limitation, the Rights and Obligations specifically referred to in Paragraph 3 of this Reassignment. It is recognized and acknowledged by the parties that the percentage of Net Profits which is payable to the Lessor as mineral production royalty under the Mining Lease is variable, and that, from and after the effective date of this Reassignment, Shield's right to receive a mineral production royalty payment at any particular time is limited to receiving 19.2864% of the total mineral production royalty payment which is payable to the Lessor under the Mining Lease at the time in question. For instance, when the Lessor is entitled to a mineral production royalty payment equal to 10% of Net Profits under Section 5.02 or 5.04 of the Mining Lease, Shield shall be entitled to receive 1.92864% (19.2864% of 10%) of that payment. Likewise, when the Lessor is entitled to a mineral production royalty payment equal to 70% of Net Profits under Section 5.02 of the Mining Lease, Shield shall be entitled to receive 13.50048% (19.2864% of 70%) of that payment. Accordingly, when the Lessor is entitled to a mineral production royalty payment equal to 45% of Net Profits under Section 5.03 of the Mining Lease, Shield shall be entitled to receive 8.67888% (19.2864% of 45%) of that payment. When the Lessor is entitled to take in kind or separately dispose of 45% of refined Products under Section 5.03 of the Mining Lease, Shield shall be entitled to take in kind or separately dispose of 8.67888% (19.2864% of 45%) of such refined Products, and shall be obligated to pay 8.67888% of the Costs of Mining and Commercial Production that are associated with the production of refined Products so taken or disposed of by Shield and 100% of any extra expenditure incurred by Tonkin Springs due to such taking in kind or separate disposition.

5. Special Warranty by Shield. Shield represents and warrants to PEX that, prior to the effective date of this Reassignment, Shield has not assigned that portion of the Rights and Obligations which is reassigned to PEX herein to any person or entity other than PEX, and that the portion of the Rights and Obligations reassigned to PEX herein is, as of the effective date of this Reassignment, free from encumbrances made or suffered by Shield or made or suffered by any person or entity claiming under Shield.

6. Modification. To the extent that the terms and conditions of the Assignment are inconsistent with or contrary to the provisions of this Reassignment, the Assignment is hereby modified by mutual agreement between Shield and PEX. As modified in this Reassignment, the Assignment remains in full force and effect.

7. Further Assurances. Each of the parties agrees to take such corporate actions and to obtain and to execute, acknowledge, and deliver to the other party such additional or further formal

documents or instruments as may be reasonably necessary in order to give full effect to the terms and conditions of this Reassignment.

8. Sole Agreement. Except for the Assignment and the Escrow Agreement, as of its effective date, this Reassignment is the sole agreement between the parties with respect to the subject matter hereof, all prior agreements between the parties with respect to the subject matter hereof (if any) being expressly rescinded and replaced hereby. Except for the Assignment and the Escrow Agreement, no prior or contemporaneous oral or written agreements of any nature whatsoever with respect to the subject matter hereof shall be binding upon the parties.
