Summary Report

This report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1, for the Orion #1-72 claims, a contiguous group of 72 lode mining claims situated in Eureka County, State of Nevada.

The work consisted of geological mapping and geochemical studies to evaluate the discovery of gold and silver metallization within the claim group and to assist in planning further exploration and development work. The work was performed between September 2, 1984 and August 26, 1985 by Ralph J. Roberts, a professional geologic consultant in partnership with Orion Ltd., 10 Desta Drive, Midland TX, 79705. Mr. Roberts has a Bachelors and a Masters Degree in Geology from the University of Washington, and a Doctors Degree from Yale University, and has been practicing as a geologist for more than 45 years.

The cost of geologic mapping, geochemical sampling and analytical services exceeded \$7500.00 and were conducted at the expense of Orion Ltd.

Geologic mapping and geochemical sampling were conducted on and around the Orion #1-72 claim group in secs. 2 and 10, T. 32 N., R. 49 E; the sampling indicated the presence of anomalous amounts of metals, including silver and gold.

That for the 1985-85 Assessment Year, between the 2nd day of September, 1984 and the 26th day of August, 1985, in excess of \$ 7500.00 worth of geologic mapping and geochemical surveys were made and performed on all of the above listed claims.

The geologic mapping showed many mineralized fault and breccia zones, trending north, northeasterly, northwesterly and east-west. These fault zones were sampled at appropriate intervals, and the samples were analyzed or assayed for significant metals including mercury, antimony, arsenic, and silver and gold. Anomalous amounts of these metals were detected, and further geochemical work is planned for subsequent years.
