THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 13200 FEET N4W FROM THE SE CORNER OF SECTION 32, TOWNSHIP 26N RANGE 49E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC 20 T26N R49E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N SOUTH DIRECTION, AND 1450 FEET IN A/N NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
