THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 13300 FEET N0°E FROM THE SE CORNER OF SECTION 32, TOWNSHIP 26N RANGE 49E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC 20, T 26N R 49E AND NW 1/4 SEC 21, T 26N R 49E MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N SOUTH DIRECTION, AND 1450 FEET IN A/N N0°E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
