THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 13500 FEET ^{N15°W} FROM THE SE CORNER OF SECTION 32, TOWNSHIP 26N, RANGE 49E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE S^W 1/4 SEC 20, T 26N, R 49E, MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N DIRECTION, AND 1450 FEET IN A/S DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
