THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1400 FEET N20°W FROM THE SE CORNER OF SECTION 32, TOWNSHIP 26N, RANGE 49E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 SEC 20, T 26N, R 49E, MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N N DIRECTION, AND 1450 FEET IN A/N S DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
