THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 15,700 FEET NW FROM THE SE CORNER OF SECTION 32, TOWNSHIP 26N, RANGE 49E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE N 1/4 SEC. 19, T. 26N, R. 49E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S DIRECTION, AND 1450 FEET IN A/AN N DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
