CERTIFICATE OF LOCATION LODE MINING CLAIM

The monumentation and marking of the above-described corners and sideline centers on the ground was completed within 20 days from the date of posting the Notice of Location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRs 517.040.
