As erected on the ground, each corner and sideline center monument consists of a white PVC post at least 4" in diameter by 4 1/2 feet in length set one foot in the ground or placed in a mound of earth and rocks and is marked as described above by an aluminum tag attached to the monument. The monumentation and marking of the above described corners and sideline centers on the ground was completed within 20 days from the date of posting the Notice of Location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040. Said claim map and description has been simultaneously filed herewith, in the County Recorder's office and the Nevada State BLM office and is by reference incorporated herein.
