CERTIFICATE OF LOCATION - HILL SITE - NEVADA

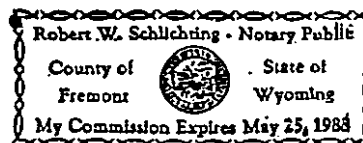
