

QUITCLAIM DEED

THIS DEED is made this 11th day of September, 1985, by and between PAN CANA RESOURCES LTD., a corporation organized and existing under the laws of the Province of Alberta, Canada, whose address for purposes hereof is 3300 Bow Valley Square 2, 205-5th Avenue, S.W., Calgary, Alberta, Canada T2P 2V7 (hereinafter referred to as "Grantor"), and PANCANA MINERALS, INC., a corporation organized and existing under the laws of the State of Colorado, U.S.A., whose address for purposes hereof is 3300 Bow Valley Square 2, 205-5th Avenue, S.W., Calgary, Alberta, Canada T2P 2V7 (hereinafter referred to as "Grantee").

WITNESSETH

WHEREAS, on August 8, 1985, Grantor and Grantee, among other parties, entered into a Stipulation and Motion With Respect to Pending Procedural Matters; Memorandum of Points and Authorities concerning a civil action pending in the United States District Court for the District of Nevada, designated by the Court as CV-R-85-80-ECR (hereinafter, the "Stipulation");

WHEREAS, said Stipulation provides that the Plaintiffs in the action consent to the dismissal of the case as against Grantor;

WHEREAS, said Stipulation states that "[i]n order to remove any title question, Pan Cana Resources Ltd. shall convey by quitclaim deed ... any interest which it might have in Sections 19, 30 and 31 and the S½S½ of Section 18, Township 36 North, Range 50 East, M.D.B.&M. to PanCana Minerals, Inc.;"

WHEREAS, this Deed is intended to comply with such requirement.

NOW, THEREFORE, for good and valuable consideration, Grantor, its successors and assigns forever, does hereby remise, release, assign, convey and QUITCLAIM unto Grantee, its successors and assigns forever, all of its right, title, interest, claim and demand which Grantor has in and to the following described

real property situate in the Counties of Eureka and Elko, State of Nevada, to wit:

Grantee hereby accepts such conveyance in order to implement the foregoing Stipulation.
