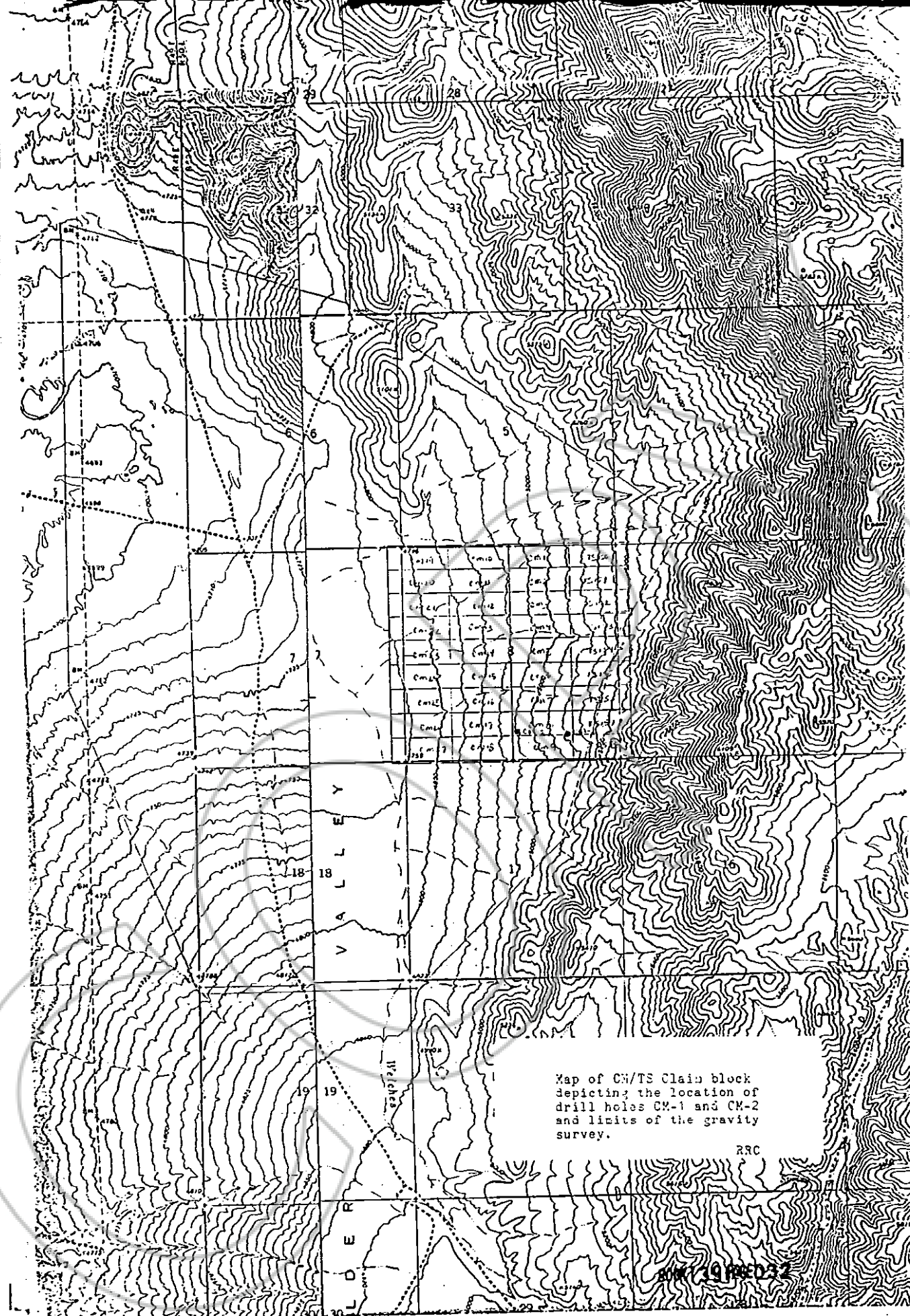

Summary Report

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the CM 1-27 and TS 150-158, a contiguous group of 36 lode mining claims situated in Eureka County, State of Nevada.

The work consisted of a geophysical survey to evaluate the discovery of gold mineralization within the claim group and to assist in planning further exploration and development work. The work was performed during the period August 19, 1985 to August 31, 1985 under the direct supervision of Gale Knutsen of 325 Skyline Dr., Elko, Nevada and Robert Craig of 234 West Ash St., Elko, NV., professional geologists employed by Newmont Exploration Limited, 1100 Lamoille Highway, Elko, Nevada. Mr. Knutsen has a Master's Degree in Geology from Washington State University, Pullman, Washington and has been a practicing geologist for over 6 years. Mr. Craig has a Master's Degree in Geology from Idaho State University, Pocatello, Idaho and has been a practicing geologist for over 7 years.

The cost of the geophysical survey exceeded \$3120 and was conducted at the expense of Newmont Exploration Limited.

The geophysical survey was conducted on and around the CM and TS claim group. (see attached map)

Further studies of the claim group are under consideration. All technical work and results are in the possession of and are considered to be the exclusive property of Newmont Exploration Limited, owners of the subject mining claims.
