

DEED OF CORRECTION

THIS INDENTURE WITNESSETH:

That the County Treasurer and Ex-officio Tax Receiver of Eureka County, Nevada, JOAN SHANGLE, caused to be recorded on August 28, 1985, in Book 138 of Official Records, Page 236, Records of Eureka County, Nevada, a County Treasurer's Tax Deed, being File No. 100157.

Said properties are subject to all the same conditions and covenants as set forth in the Original Tax Deed.


