

CERTIFICATE OF LOCATION  
(LODE)

NOTICE is hereby given that the Roger #6 lode mining claim has been located by KENNECOTT, whose office is located at P. O. BOX 11248, SALT LAKE CITY, UTAH, 84147.

By right of discovery, the locator does hereby claim all valuable minerals together with all extralateral variations allowed by law. This claim is 1,500 feet in length and 600 feet in width. The general course of this claim is East-West, and is situated in the unknown Mining District, Eureka County, State of Nevada. This claim runs from the location monument upon which this notice is posted, 1,400 feet in an east direction to the east end line, and 100 feet in a west direction to the west end line, together with 300 feet of each side of the center vein.

This claim is monumented by six posts, one at each corner and one at the center of each side line of the claim, taking the form of a rectangle. The claim is situated in the southwest quarter of Section 32, Township 35 North, Range 48 East, MDB&M.

The location of this claim in relation to some natural object or permanent monument is as follows: Corner #1 of this lode lies north 1,750 feet and east 1,450 feet from the southwest corner of Section 32, Township 35 North, Range 48 East.

The boundaries of this claim can be identified by the following description:

BEGINNING AT THE NORTHWEST CORNER OF THE CLAIM, ALSO KNOWN AS CORNER NUMBER 1;

THENCE SOUTH, 600 FEET TO THE SOUTHWEST CORNER; A.K.A. CORNER NO. 2;

THENCE EAST, 750 FEET TO THE SOUTH SIDE CENTER; A.K.A. CORNER NO. 3;

THENCE EAST, 750 FEET TO THE SOUTHEAST CORNER; A.K.A. CORNER NO. 4;

THENCE NORTH, 600 FEET TO THE NORTHEAST CORNER; A.K.A. CORNER NO. 5;

THENCE WEST, 750 FEET TO THE NORTH SIDE CENTER; A.K.A. CORNER NO. 6;

THENCE WEST, 750 FEET TO THE POINT OF BEGINNING.

All monuments consist of 4" by 4", PVC posts at least 4½ feet in length, and set in a mound of stones where such stones are available. All monuments are marked in permanent manner so as to identify the monuments.

This claim is contiguous to, and bounded by the following claims:

Roger #8 on the North.  
Roger #4 on the South.  
Roger #1 & 9 on the West.  
Roger #29 on the East.
