FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S DIRECTION, AND 1450 FEET IN A/AN N DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
