THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 5890' (N78 1/2° E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 Sec 7 T23N R51E AND THE SE 1/4 Sec 12, T23N, R50E, MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N2°24'30"W DIRECTION, AND 1450 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
