NW & SW 1/4's Sec 7 T23N, R51E, MDM.
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N N2°24'30"W
DIRECTION, AND 1450 FEET IN A/N S2°24'30"E DIRECTION,
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600
FEET WIDE AND 1500 FEET LONG.
