THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 5190' (N38 1/2° E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE & NW 1/4's Sec 12, T23N, R50E, MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N N2°24'30"W DIRECTION, AND 1450 FEET IN A/N S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
