THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4030' (N 3 1/2° E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE N E 1/4 Sec 11; NW 1/4 Sec 12; SW 1/4 Sec 1, AND SE 1/4 Sec 2, T23N, R50E, MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S2°24'30"W DIRECTION, AND 1450 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
