THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4030' (N 3 1/2° E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE N E 1/4 Sec 11; N W 1/4 Sec 12; S W 1/4 Sec 1, AND S E 1/4 Sec 2, T23N, R50E, MDH. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N S 2° 24' 30" E DIRECTION, AND 1450 FEET IN A/N N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
