NW 1/4 Sec 1 T23N, R50E, MDH.  
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S2°24'30"W  
DIRECTION, AND 1450 FEET IN A/AN N2°24'30"W DIRECTION,  
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600  
FEET WIDE AND 1500 FEET LONG.
