THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 9975' (N 3 1/2° E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 1 & SE 1/4 Sec 2 T23N R50E AND NW 1/4 Sec 1 & NE 1/4 Sec 2, T23N, R50E, MDN. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N 2° 24' 30" W DIRECTION, AND 1450 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
