THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 10050' (N7°E) FROM Roberts Creek Mountain, Section 11, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 1 T23 1/2 N R 50E AND NW 1/4 Sec 1 T23N, R50E, MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N2°24'30"W DIRECTION, AND 1450 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
