THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3420' (N89 1/2° E) FROM POINT 7437 (Shown on Roberts Mountain 15" Quad), NE 1/4 SEC 1, TOWNSHIP 23 N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW, SE, NW & NE 1/4'S SEC 6 T23N R51E MDM 1B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N N2°24'30"W DIRECTION, AND 1450 FEET IN A/N S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
